6. Discussion and possible action on Resolution No. 2020-02, a resolution of the Oklahoma Association of Chiefs of Police adopting a budget for the calendar year beginning January 1, 2021, and ending December 31, 2021, and establishing budgetary controls for the Interim Executive Director. (Steve Whitlock)

Director Whitlock discussed the budget which included a proposal staff salary in the amount of \$5,000.00 per month which is significantly cheaper than what was being paid in the past of approximately \$189,000.00. Mr. Whitlock said the salary will go up in the future, however, the \$5,000.00 will not start until the funds are in place.

Chief Babb asked if the \$5,000 was in place of the 20% or in addition to? Director Whitlock said it would be in addition to the 20%. There is also no 20% in this year's budget. OMMS has the responsibility of getting the OACP on a firm financial footing.

Chief Houser asked if the contract would have to be modified? Director Whitlock said the Resolution adopting the budget would cover the \$5,000.00 per month.

Chief Younger said he was comfortable with the \$5,000.00 for staff and the 20%.

Chief Carter said he was also ok with the \$5,000.00 and asked the end date of the contract and the renewal cost.

Steve Whitlock said the contract was 3 years with a 180-day option to opt out.
